Our Commitment

Marc G Coaching, LLC is committed to making www.MarcGCoaching.com, its public website content, digital forms, downloadable resources, and online information reasonably accessible to the widest possible audience, including individuals with disabilities.

We are continually working to improve the user experience for everyone and to apply relevant accessibility standards where reasonably achievable for a small coaching business using third-party website and digital-service platforms.

Efforts to Support Accessibility

Marc G Coaching, LLC takes the following measures to support accessibility:

Conformance Status

The Web Content Accessibility Guidelines (WCAG) define requirements for designers and developers to improve accessibility for people with disabilities. WCAG includes three levels of conformance: Level A, Level AA, and Level AAA.

Our current accessibility target is WCAG 2.2 Level AA where reasonably achievable. We also recognize that WCAG 2.1 Level AA remains a common legal and technical reference point in the United States.

Current conformance status: Partially conformant. This means that while we make reasonable efforts to improve accessibility, some parts of the website, third-party tools, documents, or embedded features may not fully conform to all WCAG success criteria at all times.

We do not represent that the website is fully accessible, fully conformant, or free from all accessibility barriers in every browser, device, assistive technology, user setting, or third-party environment.
